GOVLIB officers



SANJAY KUMAR BIHANI, Chair

Mr. Sanjay K. Bihani is a former Indian Diplomat and Library & Information Officer with over 35 years of service in the Ministry of External Affairs, Government of India. His career includes assignments at the Ministry's Headquarters in New Delhi and at Indian Diplomatic Missions in Dhaka, Kathmandu, and London. He served as an Indian Diplomat in HCI London overseeing the Press & Information Department and India House Library during 2010-13, and later at HCI, Dhaka, where his responsibilities covered Consular and Cultural Affairs including Libraries during 2022-25.

Mr. Bihani is elected as Chair of the IFLA Government Libraries Section (2025–2027). He previously served as Vice-Chair of the IFLA Regional Division Committee for Asia and Oceania (2023–2025) and as a member of the IFLA Governing Board and Professional Committee (2019–2021). During this period, he played a significant role in the IFLA Governance Review, contributed to the development of IFLA's new Statutes, and supported section action planning and funding mechanisms. As Chair of IFLA Division V, he strengthened engagement with regional sections across Asia, Oceania, Africa, and Latin America, particularly during the COVID-19 pandemic.

His contributions to Government Libraries include leading efforts to translate IFLA Guidelines into twelve languages, substantially improving global accessibility. He also brings extensive editorial experience, having served for approximately eight years with the IFLA Journal, during which he

peer-reviewed more than 100 research papers. His recent work includes the translation of the IFLA Strategy 2024–2029 into Hindi and Bengali to enhance regional outreach.

Having actively engaged in IFLA since 2005 and an IFLA Officer since 2011, he was awarded the "IFLA Scroll of Appreciation" for his distinguished contribution to IFLA's Governing Board and Committees, and dedication to improving government Libraries, the IFLA Journal and enhancing collaboration and networking within the Asia and Oceania region during the IFLA World Library and Information Congress in Dublin, Ireland in August 2022.

He has undertaken professional, diplomatic, and IFLA-related assignments in more than 35 countries across all continents.



LLARINA GONZÁLEZ SOLAR, Secretary

Dr. Llarina González Solar is an experienced librarian and researcher, currently serving as Head Librarian at the Council of the European Union. In this role, she coordinates projects to enhance access to information, managing a multicultural team and overseeing digital transformation initiatives.

She holds a BA in Conservation and Restoration of Cultural Heritage, a BA in Documentation, an MSc in Information Science in the Digital Environment, and a PhD in Knowledge Society. Her thesis explored the role of marketing in

library services, proposing a user-centred service model focusing on research support services, data management, open access, and publication strategies.

She has worked as a librarian at the Galician Regional Government and at University of A Coruña, where she handled cataloguing and reference tasks while developing research support services for students and faculty.

She has worked across various library settings, including academic, special, and government libraries, and is fluent in English, French, Spanish, and Galician. This background enables her to bridge the gap between academia and practical library management. With a passion for promoting access to knowledge and supporting researchers, Dr. González Solar continues to contribute to international publications as an author, editor, and peer reviewer.

With a strong foundation in both library science and research methodologies, she brings a comprehensive perspective to her work, combining practical expertise with a deep understanding of the evolving needs of libraries and researchers. Since 2023, she has been involved in IFLA, holding the roles of Information Coordinator (2023-2025) and Secretary (2025-2027) for GOVLIB Standing Committee.



DEEPAK KUMAR SHRIVASTAVA, Information Coordinator

Dr. Deepak Kumar Srivastava is a public librarian from India. He is widely acknowledged for transforming public library systems through inclusive, accessible, and community-centric

models. He currently serves as Divisional Librarian and Head, Government Divisional Public Library, Kota. He is also a Nodal Officer for Public Libraries of Kota Division in Rajasthan. He has also served as Sabbatical Professor at Federal University, Dustin-Ma, Nigeria and as Visiting Professor at Career Point University and Jai Minesh University, Kota.

An INLEI India Innovator and South Asia Mentor, Dr. Srivastava actively mentors emerging library leaders and drives capacity-building initiatives across the region. He was awarded the "Most Creative Thinkers Award" at the first INELI convention held at Melbourne, Australia in 2016. He has received ASLIP Best Progressive Librarian Award (2024), IFLA Wall of Fame (2020) and also listed among the top ten Next-Generation trailblazing public librarians of India (MSSRF - 2022).

Dr. Srivastava has authored 16 books and over 140 peer-reviewed research papers, and has supervised more than 25 Ph.D. scholars. His work focuses on accessibility, digital transformation, public library policy, and services for marginalized communities, including persons with disabilities and underserved populations.

Dr. Srivastava currently serves as President, Rajasthan Public Library Association (RPLA), Jaipur, and Vice President, Aksham Kalyan Sansthan, Kota. He is a Life Member of ILA, ASLIP, RPLA, SALIS, LPA, and the Nigerian Library Association (NLA).

He is recently elected to IFLA-Government Libraries Standing Committee for 2025-2029 and currently serving as Information Co-ordinator.

A Azli bin Abd Rahim is the Chief Librarian at the National Institute of Public Administration (INTAN), Public Service Department, Prime Minister's Department, Kuala Lumpur, Malaysia. He holds a Bachelor of Science in Information

Studies (Hons.) from Universiti Teknologi MARA (UiTM) and a Master of Library and Information Science from the University of Malaya.

With more than 25 years of professional experience in the Malaysian Public Service, Mr. Azli has served in prominent national institutions including the National Library of Malaysia, Parliament of Malaysia, and the Ministry of International Trade and Industry (MITI). He is currently serving at INTAN on a secondment post.

Mr. Azli has played an active leadership role in the library profession at both national and international levels. He previously served as Assistant Honorary Secretary of the Librarians Association of Malaysia and as Secretary of the Library Visits Committee for the 84th IFLA World Library and Information Congress (2018) held in Kuala Lumpur. He was a Standing Committee Member of the IFLA Government Libraries Section (2019–2023) and is currently serving his second term (2023–2027).

In 2019, he presented the paper "Library2u@MITI: An Emerging Agent Towards Empowering Innovation" at the 85th IFLA World Library and Information Congress in Athens, Greece, and also contributed as a committee member to the IFLA WLIC Mid-Year Conference held in Westminster, London.

Ana Mocé Cervera is Head of the Innovation and Reading Promotion Programs Section in the Library Service of the Department of Culture of the Generalitat of Catalonia. She holds a Diploma in Library Science and Documentation from

the University of Barcelona and a Bachelor's Degree in Documentation, specializing in Information and Documentation Systems, from the Open University of Catalonia.

Her academic background is further strengthened by a Degree in Philosophy and Educational Sciences from the University of Valencia (Extraordinary Bachelor's Award) and a Postgraduate Diploma in Logic and Philosophy of Science from the same institution.

GOVLIB co-opted six new members for geographical and regional diversity

In a rigorous exercise for co-opting of members, GOVLIB has co-opted 6 new members to strengthen the SC membership to 20. There were 9 nominations/EOIs received for GOVLIB SC through the call for co-option circulated by IFLA HQ. The new members are co-opted from regions of America, Europe and Sub-Saharan Africa for geographical and regional diversity in the committee. The new members are co-opted for the term 2025-2029.

Earlier, Mr Bihani has contacted all GOVLIB Section members, Regional Division Committees and Regional Offices to circulate the co-option call for getting nominations /EOIs. GOVLIB welcomes the new members and looking forward to work with them.

Standing Committee meetings

The first Standing Committee meeting of the IFLA Government Libraries Section for 2025–2027 term was held online on 9th September 2025. The meeting brought together officers and committee members to set priorities for the new term and to align future activities following WLIC 2025.

The Chair outlined the Section's strategic direction, highlighting the need to strengthen regional representation, increase overall membership, and improve internal engagement through regular meetings and effective use of Basecamp. Members were informed that the GOVLIB Action Plan 2025–2027 would serve as the primary framework for capacity building, member engagement, and programme development.

A key priority discussed was the planned review and updating of the Guidelines for Libraries of Government Departments, including possible restructuring of chapters and expansion to reflect emerging developments.

Communication strategy was a major focus of the meeting. Basecamp was confirmed as the sole internal communication platform, while external outreach will be strengthened through emails, coordinated use of social media and mailing lists. The creation of an Instagram account was approved, and shared responsibility for social media management was agreed.

Initial discussions were also held on WLIC 2026 in Busan, noting the shorter congress format and the importance of early coordination within Division B.

A second Standing Committee meeting was held online on 14 November 2025. The meeting brought together committee members from multiple regions to review progress, align priorities, and initiate preparations for the 2025–2027 term.



The Chair shared key updates from Division B, the Professional Council, and the Governing Board, highlighting IFLA's preference for in-person meetings around WLIC, upcoming structural consultations, and the importance of officer participation in digital skills and impact training. Members were also briefed on WLIC 2026 (Busan) and the milestone IFLA 100 Congress in London in 2027.

The minutes of the previous meeting were approved without amendment. Significant progress was reported on the co-option of new Standing Committee members, with strong regional interest received from across Africa, Asia–Oceania, Europe, and the Americas. To strengthen geographical balance, the Chair was authorised to finalise selections.

A major focus of the meeting was the Section Review, a mandatory self-assessment covering achievements of recent years. Members committed to contributing content collaboratively through Basecamp, with a submission deadline of 2 February 2026.

Discussions on collaboration with regional divisions and other professional sections emphasised the need for joint congress session at WLIC 2026. Potential thematic areas included artificial intelligence, policy support, reference services, and accessible library services. A small focus group was formed to advance this work.



The Committee also initiated planning for the GOVLIB Action Plan 2025–2027, prioritising achievable goals such as completion of the section review, co-option, revision of the Guidelines for Libraries of Government Departments, inclusion of new chapters on AI and advocacy, and wider translation of the guidelines.

Under communication strategy, the launch of a GOVLIB newsletter was endorsed, along with renewed engagement on social media platforms. Strengthening internal participation through Basecamp and forming a small communications subgroup is identified as immediate needs.

Additional decisions included reviewing the status of inactive members and introducing recognition initiatives, such as a "GOVLIB Member of the Year".

GOVLIB Annual Report (2024-25)

Overall, I think it's fair to say it was a relatively quiet year for the section in terms of events. However, following the cancellation of the 2024 WLIC in Dubai, we did nominate a panellist Greta Braungard, Academic Library Department Chair at the US Army War College to take part in the IFLA 24 Hours of IT event on 28 August 2024, on a Division B panel: "Artificial Intelligence and government, parliamentary and law libraries and official publications: A cross-sector conversation." I would like to record our thanks to Greta for taking part.

Changes in Committee members

Over the last year there have been a number of changes to the committee outside of the normal election cycle.

I will begin by mentioning Julia Hiltz who became Chair in 2023. Despite her best efforts, various health issues affecting her and her family meant she was unable to continue as Chair. She did plan to step down as Chair and from the committee this August but she brought this forward to May, and after following IFLA processes I took on the role of Chair in an interim capacity for the few months until August, besides continuing as Secretary. I'd like to thank Julia for her contribution to the committee and wish her and her family better health.

I would also like to thank Llarina who has continued in her valuable role as Information Coordinator throughout this time and given me valuable assistance during this time of uncertainty and change, such as taking the minutes for this meeting to allow me to chair it. I'm very pleased that Llarina will be the Section's Secretary for 2025-27.

As previously noted during the January meeting, Dominic Hartley from the UK retired in September 2024 and also stood down from the Section. Dominic was Secretary from 2021-23.

Brad Hinton who was a long-standing Committee Member stood down in January 2025 as he left his post in the Australian government. I will echo Julia's comments at the time in wishing both Dominic and Brad all the best for the future.

Others who did not seek re-election this year and can be considered to have stood down from the committee include Reka Ramillon- Torhany from Luxembourg, Antonmichele de Tura from Italy, Hyun Ju Kim from South Korea and Ajay Singh from India.

Last but certainly not least Neil Murray from Belgium and the European Parliament will also be leaving the committee this month. Neil was Chair for four years from 2019-23. Although this period coincided with the Covid-19 pandemic and the cancellation or changes to the annual WLIC, nonetheless we did achieve successful events for the WLICs that did happen, namely online in 2021, in Dublin in 2022 and then Rotterdam in 2023. I'm sure I speak on behalf of the entire committee when I wish Neil all the best. Looking

at the incoming committee, congratulations to those who are beginning a second term covering 2025-29 – I believe these would be Lisa Massengale from the USA and Saiyed Faheem Ali from India. And of course, we have a considerable intake of new committee members – Paola Banegas from Argentina, Zhang Shuguang from China, Vanessa Whittle from the UK, Ana Mocé from Spain, Deepak Shrivastava from India and Dolores Carungui from the Philippines.

I believe this will be a very strong committee going forward and wish you all the best. Sanjay has considerable experience as a leader within IFLA and not least within Government Libraries. Llarina has been an excellent Information Coordinator since 2023 and I am sure will bring the same enthusiasm to the role of Secretary, and although Deepak is new to the Section I believe he is the right person to take on and continue to develop the communication strategy as Information Coordinator.

This work is supported by a commitment to futureproofing IFLA, ensuring effective, transparent and innovative governance and partnerships.

The Strategy provides a flexible framework that libraries, associations and partners can adapt for their own planning. It emphasises international collaboration and positions libraries as key actors in supporting their communities.

Feature article: Central Secretariat Library and Indian Digital Repositories

The Central Secretariat Library (CSL) under the Ministry of Culture, Government of India, is one of the largest tangible treasures of knowledge next to the National Library, Kolkata, for Indian and foreign document resources. The resources of the Imperial Secretariat Library, Calcutta, which was established in 1891 during the reign of Lord Curzon and was recognised by the Imperial Library Act of 1901, are among the numerous ancient institutions that make up CSL.

The Act stated that

It was intended that it should be a library of reference, a working place for students and a repository of material for the future historians of India, in which, so far as possible, every work written about India at any time can be seen and read.

F.W. Forester, Curator of the Imperial Records Office, assembled about one thousand volumes lying about in the Writer's Building, Calcutta, received under the Press and Registration of Books Act, 1867. The Imperial Library was established on May 11, 1891, and included this collection as well as a number of collections from other secretarial libraries housed in that building. The Home Departments collection, which together with the Imperial Library, was the most significant.

Books formerly belonging to the libraries of East India College, Fort William College and the East India Company Board in London formed part of the collection. When, under the Imperial Library Act, a new Imperial Library was established, the entire collection of the erstwhile Imperial Records Office was not transferred to the new library; rather, a portion of the collection was with the Imperial Secretariat Library, to distinguish it from the Imperial Library, and which continued to function in the Writers' Building.

On 1st April 1948, the library was named the Central Secretariat Library. In 1969 the library was shifted to the newly constructed Shastri Bhawan, housing the Ministry of Education; the 'G' wing of the building was allotted to CSL.

There are 8.48 lakh documents in the library's resources and collection, including books, reports, government publications, and international publications. There is also a section dedicated to rare books with 5,545 titles, the oldest of which was acquired from the Imperial Secretariat Library in 1702. It is located in the 'G' Wing, Shastri Bhawan, New Delhi, with two branches in R.K. Puram Library (Textbook Branch); Tulsi Sadan Library (TSL) – Hindi and Regional Languages Branch.

Indian Digital Repository:

- Gazette of India: The Gazette of India is the official publication of the Government of India that carries the statutory orders and notifications. The Central Secretariat Library has digitised the Gazette from 1950 to 2002, and the data has been uploaded to the Department of Publication for online search for the benefit of the user and general public on [Gazette of India website](#).
- Committee /Commission Reports: The Indian Official Documents (IOD) Section of the Central Secretariat Library has a rich collection of (2827 approx.) reports of different committees and commissions established by the Government of India from pre-independence to post-independence. These resources have been digitised and are available through the [Central Secretariat Library digital collection](#):
- Rare Books: The rare book collection of CSL pertains to the 18th, 19th and early 20th centuries. CSL has a collection of 5545 such books which have been kept in closed access, i.e., the rare book collection in the Area Study Division of the Library. Out of these 5545 rare books, CSL has digitised 5395 rare books. [Access these digitized rare books](#).
- Gyan Bharatam: Gyan Bharatam is a national program to locate, save, digitise, and disseminate manuscripts in the National Digital Repository as living sources of knowledge for future generations. An important step in the preservation, digitalisation, and dissemination of the nation's vast manuscript history is the establishment of the National Digital Repository on February 1, 2025.

Ministry of Culture has organised the Gyan Bharatam International Conference on "Reclaiming India's Knowledge Legacy through Manuscript Heritage" from September 11–13, 2025 with the goal of preserving Indian manuscripts.

Ministry of Culture has signed Memorandums of Understanding with roughly 20 institutions across the country on October 25, 2025, for the preservation, upkeep, and digitisation of manuscripts. Rashtriya E-Pustakalaya: India's national push for digital reading access

Ministry of Education, Government of India has launched Rashtriya e-Pustakalaya (ReP) as a key national digital reading initiative under the National Digital Library of India (NDLI) framework. The initiative reflects India's strategic commitment to equitable, technology-enabled access to reading and learning resources.

ReP functions as a free, open digital library platform, offering curated e-books across age groups, subjects, and Indian languages. Designed for children, youth, and lifelong learners, the platform is accessible via web and mobile applications, ensuring nationwide reach regardless of physical library infrastructure.

Aligned with the principles of NEP 2020, Rashtriya e-Pustakalaya promotes reading culture, multilingualism, and digital inclusion. The initiative is supported institutionally through collaboration with the National Book Trust (NBT), strengthening content quality, governance, and sustainability.

For the global library community, ReP stands as a scalable model of state-supported digital public library service, demonstrating how national policy, publishing partnerships, and digital platforms can converge to reduce knowledge inequity—particularly in developing and multilingual contexts.

In Memoriam: Sandra da Conturbia (1939–2025)



The GOVLIB Section learned with great sadness of the passing of Sandra da Conturbia, who died on 23 August 2025 at the age of 86.

Born in Milan in 1939, Sandra built an outstanding international career spanning languages, political science and librarianship. Trained initially as a translator and interpreter of English and French, she later obtained a Master's degree in Political Science from the University of Turin. Following her move to the United States in 1977, she pursued librarianship and earned a Master of Library and Information Science from the University of Texas at Austin.

Sandra spent the latter part of her professional life at Texas A&M University, where she served in several senior roles at the Sterling C. Evans Library. She retired in 2006 as Director of the Policy Sciences and Economics Library, having previously worked as Senior Documents and Microtext Librarian. Her work reflected a deep commitment to access to government information, public policy resources and professional service.

She was an active member of the IFLA Government Information and Official Publications Section (1993-1997 and 1997-2001), where she contributed her expertise, international perspective and strong professional values. She also indirectly supported IFLA Government Libraries Section, her engagement was marked by collegiality, intellectual rigour and generosity of spirit.

Sandra will be remembered for her intelligence, wit and kindness, as well as for her dedication to librarianship and public service. She leaves a lasting legacy within the professional community and among the many colleagues and friends who had the privilege of working with her.
